EXPLANATION:

This emergency order closes the resident and nonresident mountain goat hunting season in the Mt. Katlian hunt zone of RG150 on Baranof Island in Game Management Unit 4. This emergency order takes effect at 11:59 PM, December 17, 2020.

REGULATION:

Therefore, the provisions of **5 AAC 85.040, Hunting seasons and bag limits for goat**, are superseded by this emergency order, and the following provisions are effective:



... Unit 4, Mt. Katlian – Drainages north and east of south fork Katlian River and south of Katlian River downstream of the Hogan Creek confluence.	Aug. 1 – Dec. 17 (General hunt only)	Aug. 1 – Dec. 17

1 goat by registration permit only, the taking
of nannies with kids is prohibited.

All other mountain goat hunting regulations in Unit 4 remain unchanged and are not affected by this emergency order.

JUSTIFICATION:

Hunt managers set a harvest quota of 3 males or 1 female for the Mt. Katlian hunt zone of mountain goat hunt RG150 on Baranof Island. Quotas are based on the most recent aerial surveys. In 2011, hunt managers devised the strategy of closing hunt zones when one female goat was harvested. This strategy has been very effective in reducing female harvest. This “one and done” policy not only reduces female harvest in areas where there may be population concerns, but helps maintain high harvest opportunities for male goats. Keeping hunters focused on avoiding female harvest maintains opportunities for more hunters to participate, especially in hunt zones that have good access.

To date, one female and one unknown goat have been harvested in the Mt. Katlian hunt zone of RG150. Unrecovered goats are counted as female for management purposes. Harvest that exceeds objectives could lead to reduced future hunting opportunities. Therefore, this zone is being closed by emergency order.
