#### SOUTHEAST ALASKA COMMERCIAL DUNGENESS CRAB SUMMER SEASON CLOSURE ANNOUNCEMENT

Petersburg...The Alaska Department of Fish and Game (department) announced today that the summer season for the commercial Dungeness crab fishery in Registration Area A (Southeast) will close by regulation **at 11:59 p.m. on Saturday, August 15, 2015**, consistent with 5 AAC 32.110. Reporting of lost pots, or pots left in a closed area in fishing condition, should be directed to Alaska Wildlife Troopers (AWT) offices in Juneau or Ketchikan.

All Dungeness crab must be landed within 24 hours of a closure [5 AAC 32.031(d)]. Vessel operators unable to meet this deadline must contact department shellfish staff within the 24 hours **following the closure** to request authorization to possess Dungeness crab for an extended period.

A person may store Dungeness crab pots in waters closed to fishing for Dungeness crab for no more than seven days after the closure to fishing for Dungeness crab in Registration Area A, if all pot doors are secured fully open and all bait and bait containers are removed [5 AAC 32.052(b)(1)(A)]. Gear storage extensions due to extreme weather or a major vessel breakdown may be obtained by contacting department shellfish staff [5 AAC 32.052(c)] before 11:59 p.m., Saturday, August 22, 2015.

The Alaska Board of Fisheries (BOF) met in January 2015 to discuss proposals for Southeast and Yakutat shellfish fisheries. At this meeting, the BOF adopted a proposal to change the start time for the summer and fall seasons of the Southeast Alaska commercial Dungeness crab fishery from 12:00 noon to 8:00 a.m. The Southeast Alaska commercial Dungeness crab fishery will reopen for the fall season at **8:00 a.m.** on Thursday, October 1, 2015 [5 AAC 32.110].
