## *Emergency Order*

**Emergency Order No. 1-KS-A-17-24**

**Issued at:** Ketchikan, Tuesday, May 21, 2024

Effective Date: 12:01 a.m. Saturday June 1, 2024

Expiration Date: 11:59 p.m. Wednesday, July 31, 2024, unless superseded by subsequent emergency order.

**EXPLANATION:** This emergency order corrects the coordinates for the southernmost entrance to Hole-in-the-Wall harbor previously established by Emergency Order 1-KS-A-10-24. Emergency Order 1-KS-A-10-24 is rescinded and king salmon bag, possession and annual limits for hatchery areas in the vicinity of Ketchikan are reestablished with the correct coordinates for the Herring Bay area.

**REGULATION:** The provisions of 5 AAC 47.021(j)(15), (16), (17) and (18) are added by this emergency order. Under this emergency order, the following provisions are effective from 12:01 a.m. Saturday, June 1 through 11:59 p.m. Wednesday, July 31, 2024:

**5 AAC 47.021. Special provisions for seasons, bag, possession, annual, and size limits and methods and means for the salt waters of the Southeast Alaska Area.**

(j) In the Ketchikan vicinity:

(15) in the waters of Thomas Basin seaward of the Stedman Street Bridge to the breakwater from June 1 through June 14:

- (A) the bag and possession limit is one king salmon, 28 inches or greater in length;
- (B) the nonresident annual harvest limit is three king salmon, 28 inches or greater in length;

(16) in the waters of George and Carroll Inlets north of a line from Mountain Point at 55° 17.57' N. lat., 131° 32.41' W. long., to Cutter Rocks Light at 55° 17.34' N. lat., 131° 31.47' W. long., to 55° 17.57' N. lat., 131° 28.18' W. long., and all waters of George Inlet and Carroll Inlet are open from June 8 through June 14:

- (A) the bag and possession limit is one king salmon, 28 inches or greater in length;
- (B) the nonresident annual harvest limit is three king salmon, 28 inches or greater in length;

(17) in the waters of Herring Bay west of a line from the southernmost entrance of Hole-In-The-Wall harbor at 55° 19. 09' N. lat., 131° 31. 21' W. long. to ADF&G markers located ½ mile north of Whitman Creek (signed and painted rocks) at 55° 20.13' N. lat., 131° 30.12' W. long., to the fresh/salt water boundary located at the mouth of Herring Cove Creek are open from June 1 through July 31:

- (A) the bag and possession limit is three king salmon, with no size limit; and,
- (B) king salmon harvested in the terminal harvest area do not count toward the nonresident annual limit.

(18) the waters of Carroll Inlet north of the latitude of Nigelius Point at 55° 33.50' N. lat., 131° 21.14' W. long., are open from June 1 through June 14:

- (A) the bag and possession limit is one king salmon, 28 inches or greater in length;
- (B) the nonresident annual harvest limit is three king salmon, 28 inches or greater in length.

**JUSTIFICATION:** The Alaska Board of Fisheries authorized the department to use its emergency order authority to increase sport bag and possession limits and modify annual limits for hatchery king salmon in terminal harvest areas when escapement is expected to be in excess of the broodstock requirements. King salmon in excess of broodstock requirements are expected to return to the Deer Mountain Hatchery, Whitman Lake Hatchery and Carroll Inlet remote release site. Therefore, the department is providing opportunity for anglers to target hatchery king salmon in the saltwater terminal areas adjacent to these locations. The terminal harvest area regulations provided for under the *District 1: Herring Bay Terminal Harvest Area Salmon Management Plan* (5 AAC 33.369) are being implemented more conservatively to protect wild king salmon stocks transiting the Ketchikan area.

King salmon bag, possession, annual limits, and open time periods established by this emergency order are identical to those previously established by emergency order 1-KS-A-10-24. This emergency order continues the previously established management provisions while correcting the coordinates delineating the southern entrance of Hole-In-The Wall harbor.

**PREVIOUS EMERGENCY ORDERS AFFECTED:**

Emergency Order 1-KS-A-10-24 released April 2, 2024, is rescinded by this emergency order.

Emergency Order 1-KS-R-09-24 establishes areas and times when king salmon may not be retained in the vicinity of Haines, Skagway, Juneau, Petersburg, Wrangell, and Ketchikan to reduce the harvest of Southeast Alaska wild king salmon stocks and meet objectives for king salmon management within the Pacific Salmon Treaty. The actions implemented by Emergency Order 1-KS-R-09-24 continue to apply in the areas and times outside the hatchery areas identified in this emergency order.
