

- 1. <u>2017 Upper Cook Inlet Finfish Meeting Location</u>: The board failed to pass a motion (2-5) to move the 2017 Upper Cook Inlet Finfish meeting from Anchorage to the Kenai/Soldotna area
- 2. Yukon Panel Report: Member Huntington provided an update to the board regarding his efforts and involvement in the Yukon Panel. The board approved his continued work with the panel.
- 3. Erosion Criteria and Temporary Committee: The board discussed its lack of criteria to be followed when deliberating on proposals impacted by coastal erosion and changes in the natural environment. To assist in developing criteria for handling regulatory changes due to coastal erosion, the board appointed Members Morisky and Mumford to a temporary committee. The Committee on Coastal Erosion

#### **Board of Fisheries**

2015 Bristol Bay Finfish Summary of Actions

Impacts on Set Gillnet Operations, authorized through 2015-279-FB, will work with representatives from the departments of Law and Natural Resources, and affected stakeholders, will work to develop criteria. The committee will provide an interim report to the board at the upcoming Alaska-Yukon-Kuskokwim Finfish meeting.

4. <u>Delegation on Changing Regulations to Incorporate Fish Resource Permits within 5 AAC 41</u>: The board approved a delegation of authority to the department to merge current regulations for the collection of fish resource permits into regulations for fish transport permits. No substantive change is anticipated and the Division of Sport Fish will carry out the regulatory change. This is viewed as a streamlining of regulations and done in support of the Administrative Order 266 to streamline regulations.
