



- In 14B, up to 100 permits for AM415, the targeted hunt.

 - Registration hunt (Kalgin Island)


Current Regulations

- Resident and nonresident hunters can take black bears over bait in the Unit 16 control area from July 1 – Oct 15.
- Residents participating in IM can take brown bears over bait in the 16B Brown Bear Control Area from July 1 – Oct 15.


Proposed Regulations

- Resident and nonresident hunters can take black and brown bears over bait from April 15 – June 30 and Aug 25 – Oct 15.
- Does not apply to Denali State Park


Black Bear Harvest and Percent Females in Unit 16, 2000 to 2013




