2019/20 SOUTHEAST ALASKA COMMERCIAL SEA CUCUMBER FISHERY ANNOUNCEMENT

Petersburg . . . The Alaska Department of Fish and Game announced today the following information concerning the commercial harvest of sea cucumbers in Southeast Alaska during the 2019/20 season,

The following areas will be open from **8:00 a.m. until 3:00 p.m., Monday, January 6, and from 8:00 a.m. until 3:00 p.m., Tuesday, January 7, 2020:**

District 1:

Rudyard Bay, East Behm Canal, and Walker Cove (Subdistricts 101-60, 71, and 73);

District 2:

Clarence Strait and Dixon Entrance (Subdistrict 102-10).

For a description of the above areas, please refer to the August 27, 2019 sea cucumber fishery news release announcing the open areas and their guideline harvest levels. The next advisory announcement following this opening will be available on **Thursday, January 9, 2020.**
