Prince William Sound Salmon Fishery Announcement #12

COPPER RIVER DISTRICT: The Copper River District will open at 7:00 am on Thursday, June 18 for a 12-hour commercial drift gillnet fishing period. Waters within the **expanded** Chinook salmon inside closure area will be **CLOSED** during this period.

The **expanded** Chinook salmon inside closure area will be defined as waters north of a line connecting the following points:

*Please note that the 'Coffee Creek West' point was replaced with 'Chinook Alternate #1'.

The grass bank marker line is defined in 5AAC 24.350(1)(A) with the exception of this year's extension of the closure line across Little Softuk (**see bold font below**). This closure line is defined with the following points:

Waters north of this line, within sloughs, and in Boswell Bay within the bay (5 AAC 24.350 (1)(A)) are closed to commercial and subsistence salmon fishing during all periods.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent in time and area with commercial fishing periods until the Copper River District is closed at the end of the season. **Additionally, waters of the Copper River District, excluding the expanded Chinook salmon inside closure area, will be OPEN to subsistence fishing from 6:00 am to 10:00 pm on Saturday, June 20.** Subsistence users may obtain subsistence permits during regular business hours. The Cordova ADF&G office is open to the public Monday - Friday, 8:00 am - 12:00 pm and 1:00 pm - 5:00 pm. **Subsistence permits are not available outside of regular office hours.** Permit holders are encouraged to call the Cordova office at 907-424-3212 or report online (<https://www.adfg.alaska.gov/Harvest/>) to provide preliminary harvest reports to assist with inseason harvest tracking.

To date, the sonar count is the 13th lowest on record (1978-2020). Cumulative commercial harvest this year is the 3rd lowest harvest to-date in the last 50 years. Cumulative sonar count through 6/16 is 260,157 fish whereas 349,503 fish are projected by this date. The 0600 count for 6/17 is 2,661 fish.

BERING RIVER DISTRICT: The Bering River District will remain closed to commercial fishing.

COGHILL DISTRICT: The Coghill District, excluding waters of the Esther and Granite Bay subdistricts and waters of the WNH SHA and THA, will open to commercial drift gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 18. Preliminary harvest estimate from the 36-hour period that started on Monday, June 15 was 12,000 chum and 13,100 sockeye salmon with 217 deliveries reported. As of June 16, 836 sockeye salmon had passed the Coghill River weir versus a minimum cumulative anticipated of 381 fish.

PWSAC cost recovery remains on hold due to slow chum salmon run entry into the Coghill District. **In response to COVID-19, all PWSAC facilities are closed to the public until further notice.**

ESHAMY DISTRICT: The Eshamy District, **excluding the MBH AGZ, SHA, and THA**, will open to commercial gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 18. Preliminary harvest estimate from the 36-hour period that started on Monday, June 15 was 63,500 sockeye and 7,400 chum salmon with 724 deliveries reported.

Cost recovery harvests will commence at MBH as run entry and hatchery escapement warrants. **In response to COVID-19, all PWSAC facilities are closed to the public until further notice.**

UNAKWIK DISTRICT: The Unakwik District will open to commercial drift gillnet and purse seine harvest for a 36-hour period starting at 8:00 am on Thursday, June 18.

MONTAGUE DISTRICT: The Port Chalmers Subdistrict, **north of 60°12.56' N. lat. and east a line from 60° 12.56'N., 147° 20.25'W. to 60° 20.00'N., 147° 14.30'W.,** will open to purse seine fishing for **36-hours** beginning at 8:00 am on Thursday, June 18 and for **36-hours** beginning at 8:00 am on Saturday, June 20. A regular schedule of three fishing periods per week is anticipated to remain in effect until further notice. **Regulatory closed waters and anadromous stream closures within the Port Chalmers Subdistrict will not be in effect until further notice.** Preliminary harvest estimate from the 36-hour period that started on Saturday, June 13 was 25,196 chum salmon with 55 deliveries reported.

SOUTHWESTERN DISTRICT: The AFK Hatchery THA and SHA will open to purse seine fishing for **48-hours** beginning at 8:00 am on Thursday, June 18. A regular schedule of two fishing periods per week is

anticipated to remain in effect until further notice. **Anadromous stream closures within the AFK Hatchery THA and SHA will not be in effect until further notice.** Preliminary harvest estimate from the 48-hour period that started on Thursday, June 11 was 17,562 chum and 354 sockeye salmon with 19 deliveries reported.

In response to COVID-19, all PWSAC facilities are closed to the public until further notice.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current. The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.
