## Bristol Bay Eastside Salmon Announcement #23 Emergency Order 36, 37, & 38

This is the Alaska Department of Fish & Game in King Salmon with an announcement for permit holders in the Naknek-Kvichak, Egegik, and Ugashik districts. The time is 3:00 p.m. and the date is Saturday, July 4, 2020.

#### Naknek-Kvichak District

On July 3, the Naknek River escapement was 4,400 for a cumulative of 309,000; the Alagnak River escapement was 2,700 for a cumulative of 33,000; and the Kvichak River escapement was 39,000 for a cumulative of 92,000. The Kvichak inriver estimate is 10,000. Harvest on July 3 was 615,000 for a cumulative of 1,450,000.

The Naknek Section will open to drift gillnet gear for an 8.5-hour period from 1:00 a.m. until 9:30 a.m. Sunday, July 5 and again for a 6-hour period from 1:00 p.m. until 7:00 p.m. Sunday, July 5. The current set gillnet period in the Naknek-Kvichak District will be extended for 25 hours from 6:00 p.m. Saturday, July 4 until 7:00 p.m. Sunday, July 5.

#### **Egegik District**

Escapement through the Egegik River tower on July 3 was 27,000 for a cumulative of 404,000 fish. Harvest on July 3 was 579,000 for a cumulative of 1.8 million fish.

Egegik District will open to commercial fishing with set gillnet gear for 8 hours from 11:00 a.m. until 7:00 p.m. Sunday, July 5. Commercial fishing with drift gillnet gear will open for 4.5 hours from 12:00 noon until 4:30 p.m. Sunday, July 5

#### **Ugashik District**

Escapement through the Ugashik River tower on July 3 was 4,680 for a cumulative of 22,000 fish.

Ugashik District will open to commercial fishing with both set and drift gillnet gear for 8 hours from 9:30 a.m. until 5:30 p.m. Sunday July 5.
