## Sand Point Commercial Salmon Fishery Advisory Announcement #11 For Emergency Order #4-FS-M-SP-07-20

Commercial salmon fishing by **set gillnet and seine gear** will be allowed for 36 hours from 6:00 a.m. Tuesday, July 14 until 6:00 p.m. Wednesday, July 15 in the following districts and sections:

Unimak District
Southwestern District, excluding the waters of the Volcano Bay Section of the Southwestern District south and east of a line from Arch Point at 55° 12.30' N. lat., 161° 54.30 ' W. long. to a point on Belkofski Peninsula at 55° 09.50' N. Lat, 161° 57.80' W. long. (Statistical Areas 284-37 through 284-39)
South Central District, excluding the portion of the West Pavlof Bay Section of the South Central District south of Black Point (55° 24.48' N. lat.; Statistical Area 283-26)
Shumagin Islands Section of the Southeastern District

Commercial salmon fishing by **drift gillnet gear** will be allowed for 36 hours from 6:00 a.m. Tuesday, July 14 until 6:00 p.m. Wednesday, July 15 in the following districts and sections:

Unimak District Ikatan Bay Section of the Southwestern District

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
