### **PORT MOLLER COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #13** **For Emergency Orders #4-FS-M-PM-13-20**

The Nelson Lagoon Section will remain open to commercial salmon fishing from 6:00 a.m. Monday, July 13 until 11:59 p.m. Thursday, July 16. The Outer Port Heiden Section will open to commercial salmon fishing from 6:00 a.m. Monday, July 13 until 6:00 p.m. Wednesday, July 15. The commercial salmon fishing season in that portion of the Ilnik Section located west of 159° 22.00'W. long will remain closed to commercial salmon fishing until further notice as per previous Advisory Announcement. The remaining portion of the Ilnik Section will remain open to commercial salmon fishing from 6:00 a.m. Monday, July 13 until 6:00 p.m. Tuesday, July 14. The Port Moller Bight and Bear River sections, and that portion of the Three Hills Section west of 159° 54.00 W. long. will remain open to commercial salmon fishing from 6:00 a.m. Monday, July 13 until 6:00 p.m. Thursday, July 16.

Per previous announcement that portion of the Three Hills Section located east of 159° 54.00'W long. will remain closed until further notice as per previous Advisory Announcement. All closed waters in the Bear River Section are as noted in regulation and those closed waters are: Frank's Lagoon at 500 yards, King Salmon at 1,000 yards, Bear River at 1,000 yards, and Sandy River at 2,000 yards.

Salmon fishery announcements will be broadcast on VHF channel 72 daily at 9:00 a.m. and 8:00 p.m. and may also be obtained from ADF&G in Port Moller at 375-2716.
