UPPER COOK INLET COMMERCIAL FISHING ANNOUNCEMENT No. 17 EMERGENCY ORDER NUMBER 2S-17-20

Upper Cook Inlet (UCI) Commercial Fishing Announcement No. 17 opens commercial salmon fishing with set gillnets in the Kenai, Kasilof, and East Foreland sections of the Upper Subdistrict from 7:00 a.m. until 7:00 p.m. on Wednesday, July 15, 2020.

As announced in UCI Commercial Fishing Announcement No. 4, gear restrictions are in place for all Upper Subdistrict set gillnet fishermen from the beginning of the season through July 31, 2020. During the July 15 fishing period, <u>legal gear in the entire Upper Subdistrict is restricted to</u> no more than two set gillnets per permit that are each not more than 35 fathoms in length and 29 meshes in depth or no more than one set gillnet per permit that is not more than 35 fathoms in length and 45 meshes in depth. As a reminder, any set gillnet that is not more than 29 meshes in depth as part of this restrictive provision must be identified at the end of the gillnet with an attached blue buoy that is not less than nine and one-half inches in diameter.

Commercial Fishing Announcement No. 17 also opens commercial salmon fishing with drift gillnets from 7:00 a.m. to 7:00 p.m. on Wednesday, July 15, 2020 in the Expanded Kenai and Expanded Kasilof sections of the Upper Subdistrict.

As of July 13, the Kasilof River sockeye salmon run is 43% complete based on average run timing and projects a final escapement of more than 478,000 fish. The minimum biological escapement goal (BEG) for Kasilof River sockeye salmon of 140,000 has been achieved. The additional fishing time provided in this announcement is intended to harvest sockeye salmon returning to the Kenai and Kasilof rivers while minimizing harvest of Kenai River king and sockeye salmon until the abundance of these stocks can be projected with more certainty.

5 AAC 21.359(e)(3)(C) *Kenai River Late-Run King Salmon Management Plan* restricts the Upper Subdistrict set gillnet fishery to no more than 24 hours per week, with a 36-hour continuous closure per week beginning between 7:00 p.m. Thursday and 7:00 a.m. Friday. With regularly scheduled fishing periods on Mondays and Thursdays no longer in effect in the Upper Subdistrict set gillnet fishery, any and all fishing time may occur only via EO. With this fishing announcement, 24 hours of the available 24 hours of EO time will have been used for the week of July 12–July 18.
