## Prince William Sound Salmon Fishery Announcement #37

<u>SEINE FISHERIES</u>: This announcement will provide time and area specifics for a broad area commercial purse seine fishing opportunity in PWS on Tuesday, July 28. VFDA is recommending an opener within Port Valdez to harvest surplus SGH pink salmon. Time and area for future commercial fishing periods targeting VFDA pink salmon in Port Valdez will be based on continued run entry and broodstock needs.

PWSAC began its cost recovery sales program on Friday, July 24, and has collected approximately 7% of the assigned pink salmon revenue goal through Sunday, July 26. Cost recovery pink salmon harvest at WNH on Sunday, July 26 resulted in an average weight of 3.6 pounds per fish and 23% female. Cost recovery fishing continues today at WNH and AFK.

An aerial survey was conducted in the Southeastern District on Monday, July 27, and indicated that pink and chum salmon escapements are within the expected ranges for the date within the district. Aerial surveys of all districts are expected to be conducted later this week, weather dependent, to further assess the strength of wild stock returns throughout PWS. It is anticipated that future fishing opportunity directed on wild stocks will initially be limited to one to two days per week. Time and area for future commercial fishing periods targeting wild stock pink and chum salmon will be dependent upon escapement, harvest, and effort.

Preliminary contribution estimates from the 14-hour fishing period on Saturday, July 25 in the Eastern District were 88% SGH and 12% Wild.

Preliminary contribution estimates from the 38-hour fishing period on Thursday, July 23 in the Coghill District were 39% SGH, 28% WNH, 29% Wild, and 3% CCH.

**EASTERN DISTRICT:** Waters of the Eastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 28.

Waters of Port Valdez east of a line from a point on shore at 61° 04.85' N., 146°30.62' W., to a point on shore at 61° 08.10' N., 146°25.00' W., will be closed to commercial fishing during this period.

Regulatory closed waters and anadromous stream closures north of a line from Potato Point to Entrance Point will not be in effect during this fishing period.

Waters inside the following Eastern District Salmon Harvest Task Force (SHTF) markers will be closed for this period to ensure escapement:

- (10) **Port Fidalgo Subdistrict:** waters east of 146°24.12' W. long.

<u>NORTHERN DISTRICT:</u> Waters of the Northern District, excluding waters of the Perry Island Subdistrict, will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 28. Anadromous stream closures within the CCH THA will not be in effect during this fishing period.

Waters inside the following Northern District Salmon Harvest Task Force (SHTF) markers will be closed for this period to ensure escapement:

- (6) **Jonah Bay:** west of a line from a shore marker at approximately 61°01.17' N. lat., 147°35.07' W. long. to a shore marker at approximately 61°00.40' N. lat., 147°35.93' W. long.;
- (7) <u>Eaglek Bay</u>: north of a line from a shore marker at approximately 60°50.66' N. lat., 147°40.27' W. long. to a shore marker at approximately 60°50.56' N. lat., 147°44.57' W. long.;

<u>COGHILL DISTRICT</u>: Waters of the Coghill District, excluding waters of the Esther Subdistrict and waters of the WNH SHA and THA, will open to commercial purse seine and drift gillnet fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 28.

**NORTHWESTERN DISTRICT:** Waters of the Northwestern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 28.

Waters inside the following Northwestern District Salmon Harvest Task Force (SHTF) markers will be closed for this period to ensure escapement:

(1) <u>Culross Pass</u>: within the passage south of a line from a shore marker at approximately 60°45.47' N. lat., 148°12.63' W. long. to a shore marker at approximately 60°45.82' N. lat., 148°13.57' W. long. and north of a line from a shore marker at approximately 60°37.48' N. lat., 148°10.12' W. long. to a shore marker at approximately 60°37.16' N. lat., 148°11.42' W. long.;

<u>MONTAGUE DISTRICT:</u> Waters of the Montague District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 28. **Anadromous stream closures and regulatory closed waters within the Port Chalmers Subdistrict are in effect.** 

**SOUTHEASTERN DISTRICT:** Waters of the Southeastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 28.

Reports are anonymous and cash rewards may be paid for successful prosecution of violations.
