Prince William Sound Salmon Fishery Announcement #47

SEINE FISHERIES: This announcement will provide time and area specifics for a broad area commercial purse seine fishing opportunity in PWS on Tuesday, August 11. PWSAC began its cost recovery sales program on Friday, July 24, and has collected 100% of the assigned pink salmon revenue goal on Sunday, August 9. Sampling of cost recovery pink salmon harvest from Sunday, August 9 resulted in an average weight of 3.4 pounds per fish and 54% female at WNH and an average weight of 3.5 pounds per fish and 47% female at CCH. The anticipated female ratio on August 9 at WNH is 40% and at CCH is 31%.

PWSAC recommends the Cannery Creek Subdistrict, AFK SHA and THA, and CCH SHA and THA, will remain closed to protect broodstock. Future CPF openings targeting PWSAC enhanced pink salmon in hatchery subdistricts will be based on fisheries performance data and broodstock collection.

EASTERN DISTRICT: Waters of the Eastern District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Tuesday, August 11. Waters of Port Valdez north of a line from Entrance Point to Potato Point will be closed to commercial fishing during this period.

NORTHERN DISTRICT: Waters of the Northern District, excluding waters of the Cannery Creek Subdistrict, and CCH SHA and THA, will open to commercial purse seine fishing for a 12-hour fishing period, from 8:00 am until 8:00 pm, on Tuesday, August 11.

COGHILL DISTRICT: Waters of the Coghill District, **excluding waters of the WNH SHA inside a line of** buoys in front of the barrier seine, will open to commercial purse seine and drift gillnet fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Tuesday, August 11.

NORTHWESTERN DISTRICT: Waters of the Northwestern District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Tuesday, August 11.

SOUTHWESTERN DISTRICT: Waters south of the latitude of 60° 11.50' N., and waters of eastern Knight Island east of Point Helen (147° 46.27' W.), will open to commercial purse seine fishing for a 12-hour period from 8:00 am until 8:00 pm on Tuesday, August 11. Waters of the AFK THA and SHA, will remain closed during this fishing period. Anadromous stream closures within the Port Elrington Subdistrict will not be in effect during this fishing period.

MONTAGUE DISTRICT: Waters of the Montague District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Tuesday, August 11.

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for a 12-hour period, from 8:00 am until 8:00 pm, on Tuesday, August 11.

In response to COVID-19, all PWSAC facilities are closed to the public until further notice.

Copies of the updated regulation booklet, 2019-2021 Commercial Salmon Fishing Regulations for Prince William Sound, are available in the Cordova ADFG office.

Under Alaska's Health Mandates 10, 11, 12, and 17 commercial fishing is an Essential Business and is part of Alaska's Essential Services and Critical Infrastructure. Commercial fishermen should ensure that all travel and other activities in support of commercial fishing operations follow protocols in Alaska COVID-19 Health Mandates. Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current. The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.
