

## Lower Cook Inlet Salmon Fishery Announcement #22

**<u>OUTER DISTRICT</u>**: Effective at 10:00 PM on August 14, the Taylor Bay Section of the Port Dick Subdistrict is closed to commercial salmon purse seine harvest and will remain closed until further notice.

The following areas are open on a schedule of Monday through Friday 16 hour fishing periods from 6:00 AM until 10:00 PM on each of those days,

-the Dogfish Bay Subdistrict,
-the Port Chatham Subdistrict,
-the Head End, Middle Creek, and Outer sections of the Port Dick Subdistrict,
- the Island Creek Section of the Port Dick Subdistrict south of a line between a point at 59° 17.03' N. lat., 151° 10.50' W. long., and another point at 59° 15.97' N. lat., 151° 05.48' W. longitude. See Figure 1 at right.
-the Nuka Island Subdistrict east of 150° 45.20' W. long.,



-the East Nuka Subdistrict, and -the Windy Bay Subdistrict. Regulatory

closed waters defined in 5AAC 21.350(f)(2) in Windy Bay are suspended. Fishing is permitted south and east of a point at 59° 13.77' N. lat., 151° 33.37' W. long. Waters in Windy Bay that are north or west of this point are CLOSED to commercial fishing.

In addition, commercial purse seine salmon fishing is permitted up to the freshwater outflows from Delight, Desire, and Delusion lakes using the definition of freshwater and saltwater boundary found in 5AAC 39.975(a)(26) on page 93 of the 2020-2022 Cook Inlet Area Commercial Salmon Fishing Regulations book. Also, 5AAC 21.350(f)(11) which pertains to the northern portion of McCarty Fjord is rescinded. The Delight Lake freshwater lagoon is **CLOSED** to commercial fishing.

**SOUTHERN DISTRICT:** Purse seine- Effective Monday, August 17 the Port Graham Subdistrict excluding the Port Graham Hatchery Special Harvest area is open on a Monday, Wednesday, and Friday schedule of 6:00 AM to 10:00 PM fishing periods on those days.

The following areas remain open to commercial common property purse seine salmon harvest on a Monday, Wednesday, and Friday schedule of 16 hour fishing periods from 6:00 AM to 10:00 PM on each of those days,

-the Humpy Creek Subdistrict,

-the Halibut Cove Subdistrict, excluding Halibut Cove Lagoon,

-the China Poot Section, excluding the China Poot SHA,

-the Neptune Bay Section, excluding the Hazel Lake SHA, and

-the Tutka Bay Subdistrict, excluding the Tutka Bay Hatchery SHA southeast of a line between a point at 59° 28.22' N. lat., 151° 27.85' W. long., and another point at 59° 28.76' N. lat., 151° 26.75' W. longitude.

**Set gillnet-** waters of the Southern District identified in 5AAC 21.330(b)(1) remain open to commercial set gillnet harvest on a regular schedule of two 48-hour fishing periods per week beginning at 6:00 AM on Mondays and Thursdays as defined in 5AAC 21.320(a)(3).

**KAMISHAK DISTRICT:** The McNeil River Subdistrict, and the Paint River Subdistrict remain closed to commercial salmon harvest until further notice. Other subdistricts of the Kamishak District as defined in 5AAC 21.299(e) remain open on a 7-days per week, 24-hour per day schedule. Waters of Chenik Lagoon east of 154° 08.33' W. long. remain open to commercial salmon harvest. Through July 27 a total of 8,355 sockeye salmon have been counted at the weir towards an SEG of 2,900-13,700 fish. Harvest from the Chenik Subdistrict is confidential due to fewer than 3 permit holders reporting deliveries from this area. An aerial survey flown on Monday, August 3 documented 1,000 sockeye salmon holding just off shore in waters south of the Kirschner Lake waterfall.

COVID-19: Under Alaska's Health Mandates 10, 17, and 18, commercial fishing is an Essential Business and

is part of Alaska's Essential Services and Critical Infrastructure. Commercial fishermen should ensure that all travel and other activities in support of commercial fishing operations follow protocols in Alaska COVID-19 Health Mandates.
