## Prince William Sound Salmon Fishery Announcement #56

<u>SEINE FISHERIES</u>: This announcement will detail purse seine fishing periods commencing on Monday, August 24; Tuesday; August 25; and Wednesday, August 26. An estimated 150,000 pink salmon were harvested in PWS on Friday, August 21. The cumulative PWS pink salmon harvest through August 21 is estimated at 17.85 million CPF and 3.3 million cost recovery fish, for a total of 21.15 million fish. The 5-year even-year average (2010–2018) cumulative PWS pink salmon harvest (cost recovery and CPF fish) through August 21 is 33.5 million fish.

PWSAC recommends the AFK, CCH, and WNH SHAs, THAs, and corresponding hatchery subdistricts remain closed to build broodstock. PWSAC currently estimates there are approximately 285,000 pink salmon near the AFK hatchery and needs approximately 363,000 pink salmon for broodstock; 262,500 pink salmon within the CCH SHA and needs approximately 357,000 pink salmon for broodstock; 270,000 pink salmon within the WNH SHA and needs approximately 283,000 pink salmon for broodstock.

**EASTERN DISTRICT:** Waters of Eastern District will open to commercial purse seine fishing for 12-hour periods, from 8:00 am until 8:00 pm on Monday, August 24; 8:00 am until 8:00 pm on Tuesday, August 25; and 8:00 am until 8:00 pm on Wednesday, August 26. **Waters of Port Valdez north of a line from Entrance Point to Potato Point will be closed to commercial fishing during this period.** 

**NORTHERN DISTRICT:** Waters of the Northern District, **east of 147°31.15 W.**, will open to commercial purse seine fishing for a 12-hour fishing period, from 8:00 am until 8:00 pm, on Tuesday, August 25.

<u>COGHILL DISTRICT:</u> Waters of the Coghill District, **excluding waters of the Esther Subdistrict, Granite Bay Subdistrict, and WNH SHA and THA,** will open to commercial purse seine and drift gillnet fishing for 12-hour periods, from 8:00 am until 8:00 pm on Monday, August 24; 8:00 am until 8:00 pm on Tuesday, August 25; and 8:00 am until 8:00 pm on Wednesday, August 26.

**NORTHWESTERN DISTRICT:** Waters of the Northwestern District will open to commercial purse seine fishing for 12-hour periods, from 8:00 am until 8:00 pm on Monday, August 24; 8:00 am until 8:00 pm on Tuesday, August 25; and 8:00 am until 8:00 pm on Wednesday, August 26.

**SOUTHWESTERN DISTRICT:** Southwestern District will be closed for these commercial fishing periods.

**MONTAGUE DISTRICT:** Waters of the Montague District will open to commercial purse seine fishing for 12-hour periods, from 8:00 am until 8:00 pm on Monday, August 24; 8:00 am until 8:00 pm on Tuesday, August 25; and 8:00 am until 8:00 pm on Wednesday, August 26.

**SOUTHEASTERN DISTRICT:** Waters of the Southeastern District will open to commercial purse seine fishing for 12-hour periods, from 8:00 am until 8:00 pm on Monday, August 24; 8:00 am until 8:00 pm on Tuesday, August 25; and 8:00 am until 8:00 pm on Wednesday, August 26.

In response to COVID-19, all PWSAC facilities are closed to the public until further notice.

Copies of the updated regulation booklet, 2019-2021 Commercial Salmon Fishing Regulations for Prince William Sound, are available in the Cordova ADFG office.

Under Alaska's Health Mandates 10, 11, 12, and 17 commercial fishing is an Essential Business and is part of Alaska's Essential Services and Critical Infrastructure. Commercial fishermen should ensure that all travel and other activities in support of commercial fishing operations follow protocols in Alaska COVID-19 Health Mandates. Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current. The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.
