## KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #38 For Emergency Order #4-FS-K-38-20

There will be a <u>96-hour extension</u> to the current commercial salmon fishing period from 6:00 p.m. Monday, September 7 to 6:00 p.m. Friday, September 11 in the following areas:

- The Outer Karluk Section of the Southwest Kodiak District;
- The Central and North Cape sections of the Northwest Kodiak District; and,
- The Humpy-Deadman, Cape Alitak, Alitak Bay, Moser Bay, and Olga Bay sections of the Alitak District.

There will be a <u>78-hour</u> commercial salmon fishing period from **noon Tuesday**, **September 8** to **6:00 p.m. Friday**, **September 11** in the following areas:

- The Outer Ayakulik Section of the Southwest Kodiak District;
- The **Afognak District** (except the Outer Kitoi Bay and Izhut Bay sections remain open until further notice; and the Inner Kitoi Bay Section remains closed);
- The **Mainland District**;
- The Sharatin Bay, Kizhuyak Bay, Terror Bay, and Inner Uganik Bay sections of the Northwest Kodiak District;
- The **Eastside Kodiak District**; and,
- The Northeast Kodiak District.

## As Previously Announced:

The following areas remain open until further notice:

The Outer Kitoi Bay and Izhut Bay Section of the Afognak District.

<u>Until further notice</u>, in that portion of the Northwest Kodiak and Southwest Kodiak districts south of the latitude of Cape Kuliuk, Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear in the commercial salmon fishery and must be returned to the water unharmed.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office. Recent salmon fishery information may be obtained by calling the Department's 24-hour record-a-phone at 486-4559.
