Sand Point Commercial Salmon Fishery Advisory Announcement #10 For Emergency Order #4-FS-M-SP-08-21

Commercial salmon fishing by **set gillnet and seine gear** will be allowed for 36 hours from 6:00 a.m. Monday, July 26 until 6:00 p.m. Tuesday, July 27 in the following districts and sections:

Unimak District
Southwestern District
South Central District
Shumagin Islands Section of the Southeastern District

Commercial salmon fishing by **drift gillnet gear** will be allowed for 36 hours from 6:00 a.m. Monday, July 26 until 6:00 p.m. Tuesday, July 27 in the following districts and sections:

Unimak District
Ikatan Bay Section of the Southwestern District

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
