This is the Alaska Department of Fish & Game in King Salmon with an announcement for permit holders in the Naknek-Kvichak, Egegik, and Ugashik districts. The time is 12:00 noon and the date is Sunday, June 26, 2022.

Naknek-Kvichak District

On June 25, Naknek River escapement was 19,000 fish for a cumulative of 103,000. Kvichak River escapement was 48,000 for a cumulative of 55,000. The Kvichak inriver estimate is 60,000. The Naknek-Kvichak District harvest from June 25 was 184,000 fish. There are 173 vessels registered to fish in the district.

The Naknek-Kvichak District will open to drift gillnet gear for an 18.5-hour period from 11:30 p.m. Sunday, June 26 until 6:00 p.m. Monday, June 27. The current set gillnet period in the Naknek-Kvichak District will be extended for 24.5 hours from 5:30 p.m. Sunday, June 26 until 6:00 p.m. Monday, June 27.

Egegik District

Egegik Tower passed 132,000 fish on June 25, bringing the season total to 337,000. Current escapement is projecting to exceed the upper end of the escapement goal range. Egegik District harvest from June 25 was 316,000 fish, for a season total of 1.7 million.
