SOUTHEAST ALASKA SALMON PURSE SEINE FISHERY ANNOUNCEMENT

District 1

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Sunday, July 31, 2022:**

Section 1-F: will be open south and east of a line from California Head at 55°19.58' N lat, 131°29.25' W long to Spire Island Light at 55°16.08' N lat, 131°29.98' W long to a point on the western shore of Gravina Island at 55°14.91' N lat (the latitude of the northernmost tip of Cone Point) then due west to the District 2 boundary with the following restrictions:

Carroll Inlet: will be closed north of the latitude of California Head at 55°19.58' N lat;

Boca de Quadra: will be closed south and east of a line from Foggy Point Light at 54°55.44' N lat, 130°58.66' W long to Black Rock Light at 55°01.42' N lat, 131°03.59' W long to the southernmost tip of Black Island at 55°07.91' N lat, 131°04.85' W long then due east to the mainland shore;

Nichols Passage: will be closed north of the latitude of the southernmost tip of Dall Head at 55°07.74' N lat;

Thorne Arm: will be closed north and east of a line from the southernmost tip of Moth Point located at 55°15.92' N lat, 131°19.69' W long to the northernmost tip of Cone Point at 55°14.91' N lat, 131°19.04' W long.

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Monday, August 1, 2022:**

Section 1-F: will be open south and east of a line from California Head at 55°19.58' N lat, 131°29.05' W long to Spire Island Light at 55°16.08' N lat, 131°29.98' W long to a point on the western shore of Gravina Island at 55°14.91' N lat, (the latitude of the northernmost tip of Cone Point) then due west to the District 2 boundary and north of a line from Lucky Point at 55°12.62' N lat, 131°15.92' W long to Point White at 54°56.06' N lat, 131°29.86' W long then due west to the District 2 boundary with the following restrictions:

Carroll Inlet: will be closed north of the latitude of California Head at 55°19.58' N lat;

Nichols Passage: will be closed north of the latitude of the southernmost tip of Dall Head at 55°07.74' N lat;

Thorne Arm: will be closed north and east of a line from the southernmost tip of Moth Point located at 55°15.92' N lat, 131°19.69' W long to the northernmost tip of Cone Point at 55°14.91' N lat, 131°19.04' W long.

District 2

The following area will be open to purse seining from **5:00 a.m., Sunday, July 31, through 8:00 p.m., Monday, August 1, 2022:**

District 2: will be open south of the latitude of Figgins Point at 55°33.14' N lat with the following restrictions:

Cleveland Peninsula: will be closed within 3.0 nautical miles (nmi) of the mainland shoreline;

Cholmondeley Sound and contiguous waters: will be closed south of a line from the northernmost tip of Chasina Point at 55°16.78' N lat, 132°01.65' W long to Skin Island Light at 55°18.09' N lat, 132°04.37' W long to the northernmost tip of Clover Point at 55°18.72' N lat, 132°07.87' W long;

Kasaan Bay, Skowl Arm, and contiguous waters: will be closed west of the longitude of Skowl Point Light at 132°16.18' W long;

Kendrick Bay: will be closed west of 131°59.00' W long;

McLean Arm: will be closed west of 131°57.80' W long;

Moira Sound: will be closed west of the longitude of the easternmost entrance of Menefee Anchorage at 132°00.35' W long.

District 3

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Sunday, July 31, 2022:**

Section 3-B: will be open west of a line **from the southernmost tip of Point Desconocida at 55°41.64' N lat, 133°31.74' W long** to the northernmost tip of Point Animas at 55°32.06' N lat, 133°27.37' W long to the southwesternmost tip of Point Arboleda at 55°19.10' N lat, 133°27.81' W long with the following restrictions:

Port Asumcion: will be closed north and west of a line from Point Cosinas at 55°21.80' N lat, 133°30.64' W long to a point west of Point Maria at 55°22.04' N lat, 133°30.26' W long;

Portillo Channel: will be closed north of a line from the southernmost tip of Point Amargura at 55°27.00' N lat, 133°21.64' W long to Arrecife Point at 55°27.07' N lat, 133°25.75' W long and south of a line from the northernmost tip of Point Animas at 55°32.06' N lat, 133°27.37' W long to Point Delgada at 55°30.80' N lat, 133°28.76' W long.

The following area will be open to purse seining from **5:00 a.m., Sunday, July 31, through 8:00 p.m., Monday, August 1, 2022:**

Section 3-A: will be open south of the latitude of **Mellen Rock Light at 55°01.60' N lat** with the following restrictions:

Dall Island Shore: will be closed west of a line from the southernmost tip of Reef Point at 55°03.62' N lat, 132°58.33' W long to Shoe Island Light at 54°57.10' N lat, 132°44.78' W long to the westernmost tip of Datzkoo Point at 54°43.80' N lat, 132°41.83' W long;

Hassiah Inlet and Mabel Bay: will be closed east of the longitude of 132°35.00' W long and south of the latitude of the northernmost tip of Helen Island at 54°59.43' N lat;

Klakas Inlet: will be north of 54°57.16' N lat (the southernmost entrance to Max Cove);

Kassa Inlet: will be closed east of the longitude of Kassa Point at 132°31.62' W long;

Max Cove: will be closed east of 132°24.00' W long.

Section 3-B: will be open west of a line from Cape Lynch at 55°46.87' N lat, 133°42.10' W long to the northernmost tip of Point Animas at 55°32.06' N lat, 133°27.37' W long to the southwesternmost tip of Point Arboleda at 55°19.10' N lat, 133°27.81' W long with the following restrictions:

Port Asuncion: will be closed north and west of a line from Point Cosinas at 55°21.80' N lat, 133°30.64' W long to a point west of Point Maria located at 55°22.04' N lat, 133°30.26' W long;

Portillo Channel: will be closed north of a line from the southernmost tip of Point Amargura at 55°27.00' N lat, 133°21.64' W long to Arrecife Point at 55°27.07' N lat, 133°25.75' W long and south of a line from the northernmost tip of Point Animas at 55°32.06' N lat, 133°27.37' W long to Point Delgada at 55°30.80' N lat, 133°28.76' W long.

Section 3-C: will be open west of the longitude of the southernmost tip of Marble Island at 133°26.89' W long with the following restrictions:

Holbrook Arm, Van Sant Cove, and contiguous waters: will be closed north and west of a line from Limestone Point Light at 55°56.31' N lat, 133°36.96' W long to the southernmost tip of Holbrook Point at 56°00.30' N lat, 133°28.64' W long;

Tokeen Bay: will be closed east of the southernmost tip of Holbrook Point at 133°28.64' W long.

District 4

The following area will be open to purse seining from **5:00 a.m., Sunday, July 31, through 8:00 p.m., Monday, August 1, 2022:**

District 4: will be open.

District 5

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m. Sunday, July 31, 2022:**

Shakan Bay: will be open east of the longitude of Station Island Light at 133°37.55' W long.

District 9

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m. Sunday, July 31, 2022:**

Section 9-B: will be open within 3.0 nmi of the Admiralty Island shoreline east of 134°25.00' W long with the following restriction:

Eliza Harbor: will be closed north of 57°10.58' N lat.

District 10

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Sunday, July 31, 2022:**

District 10: will be open within 3.0 nmi of the Admiralty Island shoreline south of the latitude of Gambier Island Light at 57°26.13' N lat with the following restrictions:

Gambier Bay: will be closed north of the latitude of Gambier Island Light at 57°26.13' N lat;

Snug Cove: all waters will be closed;

Pybus Bay: will be closed north of the latitude of Point Pybus at 57°18.43' N lat.

District 12

The following areas will be open to purse seining from **5:00 a.m. to 8:00 p.m., Sunday, July 31, 2022:**

Point Augusta: will be open within 1.0 nmi of the Chichagof Island shoreline east of a line from a marker at 58°02.44' N lat, 134°57.50' W long to a point at 58°03.00' N lat 134°57.85' W long, south of 58°03.00' N lat, and north of the latitude of a regulatory marker at 58°01.63' N lat (located 1.0 nmi south of Point Augusta Light).

Admiralty Island shoreline: will be open within 1.0 nmi of the Admiralty Island shoreline south of the latitude of Point Marsden at 58°03.40' N lat and **north of the latitude of Parker Point at 57°36.73' N lat.**

Hidden Falls THA: will be open within approximately 2.0 nmi of the Baranof Island shoreline in the waters of Chatham Strait south of the latitude of South Point at 57°16.28' N lat, north of 57°06.76' N lat, and west of a line from a point offshore at 57°16.28' N lat, 134°48.00' W long to a point offshore at 57°06.76' N lat, 134°43.00' W long with the following restriction:

Kasnyku Bay: will be closed north and west of a line from North Point at 57°13.36' N lat, 134°50.53' W long to the northernmost tip of Round Island at 57°12.68' N lat, 134°50.48' W long to the southernmost tip of Round Island at 57°12.56' N lat, 134°50.51' W long to a point on the Baranof Island shoreline at 57°12.48' N lat, 134°50.98' W long.

The following areas will be open to purse seining from **5:00 a.m. to 8:00 p.m., Monday, August 1, 2022:**

Chichagof Island, Catherine Island, and Baranof Island shorelines: will be open within 2.0 nmi of the Chichagof Island, Catherine Island, Baranof Island shorelines, and the Section 13-C boundary, south of the latitude of **South Passage Point at 57°45.84' N lat** and north of the latitude of South Point at 57°16.28' N lat with the following restriction:

Kelp Bay: will be closed west of a line from North Point at 57°17.61' N lat, 134°49.89' W long to South Point at 57°16.28' N lat, 134°51.80' W long;

Catherine Island: waters of an unnamed cove will be closed north and west of a line from a point at 57°20.15' N lat, 134°48.70' W long to a point at 57°20.29' N lat, 134°48.43' W long.

Admiralty Island shoreline: will be open within 1.0 nmi of the Killisnoo and Admiralty Islands shoreline **south of the latitude of Point Samuel at 57°28.45' N lat** and **north of the latitude of Point Wilson at 57°08.16' N lat (Hood Bay, Chaik Bay, Whitewater Bay, and Wilson Cove to normal markers).**

The following area will be open to purse seining from **5:00 a.m., Sunday, July 31, through 8:00 p.m., Monday, August 1, 2022:**

Tenakee Inlet: will be open **west of line from East Point at 57°48.33' N lat, 134°56.92° W long to a point at 57°46.34' N lat, 134°56.07' W long to South Passage Point at 57°45.84' N lat, 134°56.33' W long**, and east of 135°27.84' W long (normal markers).

District 13

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Sunday, July 31, 2022:**

Section 13-A: **Portlock Harbor, Ogden Passage, Smooth Channel, Khaz Bay, and Slocum Arm: will be open east of a line from Khaz Point at 57°30.15' N lat, 136°01.33' W long to Ninefoot Shoal buoy at 57°34.83' N lat, 136°05.82' W long to the southernmost tip of Herbert Graves Island at 57°38.40' N lat, 136°10.90' W long to the southernmost tip of Point Hogan at 57°41.38' N lat, 136°15.81' W long to the southernmost tip of Hill Island at 57°43.67' N lat, 136°16.57' W long to a point on the Chichagof Island shoreline at 57°46.11' N lat, 136°16.85' W long with the following restrictions:**

Slocum Arm: will be closed south and east of 135°56.28' W long;

Klag Bay, Lake Anna, and Sisters Lake: will be closed north and east of a line from 57°36.93' N lat, 136°06.42' W long to 57°36.74' N lat, 136°05.78' W long;

Ford Arm: will be closed east of 136°00.03' W long.

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Monday, August 1, 2022:**

Section 13-A: Salisbury Sound and Peril Strait will be open east of the longitude of Kalinin Point at 135°48.07' W long and north of 57°18.11' N lat with the following restriction:

Sukoi Inlet: will be closed south of a line from Sukoi Point at 57°19.32' N lat, 135°41.90' W long to Hayward Point at 57°19.32' N lat, 135°41.16' W long;

Peril Strait: will be closed north of 57°23.31' N lat.

Section 13-C: will be open east of 135°09.44' W long with the following restriction:

Sitkoh Bay and Florence Bay: will be closed north and west of line from Point Craven at 57°27.95' N lat, 134°52.18' W long to Point Hayes at 57°28.83' N lat, 134°50.33' W long.

The following area will be open to purse seining from **5:00 a.m., Sunday, July 31, through 8:00 p.m., Monday, August 1, 2022:**

Section 13-B: Sitka Sound and contiguous waters: will be open north of a line from Inner Point on the Kruzof Island shoreline at 57°05.50' N lat, 135°34.28' W long to Makhnati Rock Light at 57°02.16' N lat, 135°23.79' W long to Surf Rock Light at 57°01.92' N lat, 135°22.59' W long to Simpson Rock Light at 57°01.15' N lat, 135°20.75' W long to Tsaritsa Rock Light at 57°01.24' N lat, 135°19.48' W long to Silver Point at 57°00.80' N lat, 135°18.09' W long with the following restrictions:

Silver Bay: will be closed east of a line from Entry Point at 57°01.96' N lat, 135°15.00' W long to a point on the Baranof Island shoreline at 57°01.58' N lat, 135°14.58' W long;

Camp Coogan Bay: will be closed east of 135°14.87' W long;

Crescent Bay: will be closed in waters enclosed by a line from the east end of the John O'Connell Bridge at 57°02.87' N lat, 135°20.35' W long to The Twins Light at 57°02.06' N lat, 135°18.79' W long to the **westernmost tip of Cannon Island at 57°02.60' N lat, 135°18.18' W long;**

Olga Strait: will be closed north of 57°11.01' N lat and south of the latitude of Creek Point at 57°12.94' N lat;

Mosquito Cove: will be closed south and east of a line from a point at 57°08.53' N lat, 135°22.50' W long to a point at 57°08.63' N lat, 135°22.35' W long.

The following area will be open to purse seining from **5:00 a.m., Sunday, July 31, through 8:00 p.m., Tuesday, August 2, 2022:**

Section 13-B: Redoubt Bay, Kanga Bay, and contiguous waters will be open east of 135°22.76' W long.

District 14

The following area will be open to purse seining from **5:00 a.m. to 8:00 p.m., Sunday, July 31, 2022:**

Section 14-B: will be open south of the latitude of Crist Point at 58°10.27' N lat.

Section 14-C: will be open within 1.0 nmi of the Chichagof Island shoreline.

Chinook Salmon Landing Restrictions: Chinook salmon 28 inches or greater in length may **NOT be retained in Districts 1 and 2**. Chinook salmon 28 inches or greater in length **MAY be retained and sold in Districts 3, 4, 5, 10, 12, 13, and 14**. Chinook salmon less than 28 inches may be retained but not sold. All Chinook salmon harvested in the Deep Inlet Terminal Harvest Area (THA) must be retained and may be sold. The differential Chinook salmon retention is due to the wild stock Chinook salmon run timing in the inside waters of Southeast Alaska.

When under nonretention of Chinook salmon 28 inches or larger, purse seine fishermen are encouraged to quickly release Chinook salmon in a manner that minimizes mortality. If Chinook salmon greater than 28 inches are retained, the fisherman is in violation and may be issued a citation. Retained Chinook salmon will be donated, and the fisherman may be subject to the cost associated with processing the fish for donation. On the fish ticket, the number and weight of the fish must be recorded and the disposition code "86-Donated" must be used.

Fishermen, tenders, and processors are reminded that all salmon, including steelhead, commercially harvested but retained for personal use and not sold, must be reported on fish tickets at the time of delivery.

To date, 760 sockeye salmon have been counted at the Hugh Smith Lake weir. The current weir count projects to a total escapement of approximately 1,700 sockeye salmon, well below the optimal escapement goal range of 8,000–18,000 sockeye salmon. The department will continue to monitor the sockeye salmon escapement as the season progresses and may take management actions in District 1 through statistical week 33.

The next seine announcement will be issued on **Tuesday, August 2, 2022**.
