Prince William Sound Salmon Fishery Announcement #7

COPPER RIVER DISTRICT: The Copper River District will remain closed to commercial drift gillnet fishing. The Copper River District will open to subsistence fishing at 7:00 am on Thursday, June 6 for a 12-hour fishing period. Waters within the Chinook salmon **expanded** inside closure area will be **CLOSED** during this subsistence fishing period. The next commercial opening of the Copper River District may occur as early as Friday, June 7. **Permit holders are advised that unscheduled announcements providing additional fishing opportunity based on Miles Lake sonar passage trends may occur at any time inseason.**

The **expanded** Chinook salmon inside closure area will be defined as waters north of a line connecting the following points:

*Please note that the 'Coffee Creek West' point was replaced with 'Chinook Alternate #1'.

The grass bank marker line is defined in 5 AAC 24.350(1)(A) with the exception of this year's extension of the closure line across Little Softuk (**see bold font below**). This closure line is defined with the following points:

Waters north of this line, within sloughs, and in Boswell Bay within the bay (5 AAC 24.350 (1)(A)) are closed to commercial and subsistence salmon fishing during all periods.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent in time and area with commercial fishing periods until the Copper River District is closed at the end of the season. Additionally, waters of the Copper River District, excluding the expanded Chinook salmon inside closure area, will open to subsistence fishing from 6:00 am to 10:00 pm on all Saturdays from May 18 through October 28. Prince William Sound Management Area salmon subsistence permits may be obtained through any ADF&G office or online (<https://www.adfg.alaska.gov/Store/>). In Cordova, permits will be available during normal business hours Monday through Friday from 8:00 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m. To assist with inseason harvest tracking, permit holders are encouraged to call the Cordova office at 907-424-3212 or report online (<https://www.adfg.alaska.gov/Harvest/>) to provide preliminary harvest reports.

Cumulative sonar count through 6/4 is 76,663 fish whereas 213,839 fish are expected by this date. The 0600 count for 6/5 is 2,930 fish.

BERING RIVER DISTRICT: Bering River District will remain closed to commercial drift gillnet fishing.

COGHILL DISTRICT: The Coghill District, excluding the Esther Subdistrict and the WNH THA and SHA, will open to commercial drift gillnet harvest for a 36-hour fishing period starting at 8:00 am on Thursday, June 6. Waters of Port Wells and College Fiord, north of 60° 55.81' N., and east of a line from Pakenham Point (61° 00.45' N., 148° 04.85' W.) to 60° 55.81' N., 148° 10.92' W., will open to commercial drift gillnet harvest for an 84-hour period starting at 8:00 am on Thursday, June 6.

PWSAC requests that the Esther Subdistrict and the WNH SHA and THA remain closed. Cost recovery harvests will commence at WNH as run entry and hatchery escapement warrants.

ESHAMY DISTRICT: The Eshamy District, excluding the MBH AGZ, will open to commercial gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 6.

PWSAC recommends that the MBH AGZ remain closed to allow for hatchery operations. Cost recovery harvests will commence at MBH as run entry and hatchery escapement warrants.

MONTAGUE DISTRICT: The Port Chalmers Subdistrict, **north of 60°12.56' N. lat. and east of a line from 60° 12.56'N., 147° 20.25'W. to 60° 20.00'N., 147° 14.30'W.**, will open to purse seine fishing for a 36-hour period starting at 8:00 am on Saturday, June 8. Preliminary harvest for the 36-hour period ending on June 1 was 4,500 chum salmon with 7 reported deliveries. Regulatory closed waters and anadromous stream closures within the Port Chalmers Subdistrict will not be in effect until further notice. A total of 920,000 chum salmon are forecast to return to Port Chalmers Subdistrict. Historical harvest timing for these chum salmon is from June 1 – July 27.

SOUTHWESTERN DISTRICT: The AFK Hatchery THA and SHA will open to purse seine fishing for a 36-hour period starting at 8:00 am on Saturday, June 8. Anadromous stream closures within the AFK Hatchery THA and SHA will not be in effect until further notice. A total of 240,000 chum salmon are forecast to return to AFK Hatchery. Historical harvest timing for these chum salmon is from June 1 – July 27.

The next scheduled salmon fisheries announcement is anticipated to be at 2:00 pm Saturday, June 8.
