## SOUTHEAST ALASKA PERSONAL USE GOLDEN KING CRAB AND TANNER CRAB FISHERIES CLOSURE

The 2023/2024 Southeast Alaska personal use golden king crab and Tanner crab fisheries close by regulation [5 AAC 77.664(c)(2) & 5 AAC 77.666(c)(1)] at 11:59 p.m. on June 15, 2024, and will reopen at 12:00 a.m. on July 1, 2024.
