### Sand Point Commercial Salmon Fishery Advisory Announcement #11 For Emergency Order #4-FS-M-SP-07-24

Commercial salmon fishing by **purse seine and set gillnet gear** will be allowed for 36 hours from 6:00 a.m. Sunday, July 14 until 6:00 p.m. Monday, July 15 in the following districts and sections:

Unimak District  
Southwestern District  
South Central District  
Shumagin Islands Section of the Southeastern District

Additionally, **Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear in the Unimak, Southwestern, South Central, and Southeastern Districts of Area M** during a commercial salmon fishery and must be returned to the water unharmed.

Commercial salmon fishing by **drift gillnet gear** will be allowed 36 hours from 6:00 a.m. Sunday, July 14 until 6:00 p.m. Monday, July 15 in the following districts and sections:

Unimak District  
Ikatan Bay Section of the Southwestern District

All closed waters in the above locations will be as described in the regulation book or as adjusted by emergency order.
