KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #10 For Emergency Order #4-FS-K-10-24

The following areas will be **extended** from **9:00 p.m. Monday, July 15 <u>until further notice</u>:**

- The Izhut Bay, Outer Kitoi Bay, and Inner Kitoi Bay Sections of the Afognak District.

Closed Water Adjustments:

Closed waters are **reduced** from **9:00 p.m. Monday, July 15** <u>until further notice</u>:

- In the **Inner Kitoi Bay Section**, to the ADF&G markers located in Little Kitoi and Big Kitoi bays (near stream #s 252-323 and 252-324).

As previously announced:

The following areas will <u>close</u> as scheduled at 9:00 p.m. Monday, July 15:

- The Outer Ayakulik Section of the Southwest Kodiak District;
- The Northwest Kodiak District (except the Kizhuyak Bay Section will remain closed);
- The Northeast Kodiak District;
- The Eastside Kodiak District;
- The **Afognak District** (except the Duck Bay, Izhut Bay, Outer Kitoi Bay, and Inner Kitio Bay Sections remain open until further notice); and
- The Mainland District.

Closed Water Adjustments:

Closed waters in **Saltery Cove** are the normal closed waters as described in regulation.

The following areas will remain **<u>open until further notice</u>**:

The Duck Bay Section of the Afognak District.

<u>Until further notice</u>, in the Kodiak Area (including the Mainland District) Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear in the commercial fishery and must be returned to the water unharmed.

Concerning the North Shelikof Strait Fishery:

Short notice, inperiod closures may occur for seine fisheries in the Seaward Zones of the North Shelikof Strait area (**including the Cape Igvak Section**), as designated in the North Shelikof Strait Sockeye Salmon Management Plan (5 AAC 18.363). Closure announcements may occur at 8:30 a.m., 10:00 a.m., noon, 2:00 p.m., 5:00 p.m., or 8:00 p.m. on VHF channel 6.

<u>Cost recovery fisheries</u> have begun in the **Spiridon Bay Special Harvest Area (SHA)** and the **Spiridon Bay SHA** will remain <u>closed</u> to common property fishing. Fishery opportunities in the Spiridon Bay SHA will be dependent on the ability to meet KRAA cost recovery needs. Cost recovery information can be obtained by calling 486-6559.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office.
