KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT #16 For Emergency Order #4-FS-K-16-24

There will be a **48-hour extension** to the current commercial salmon fishing period from **9:00 p.m. Saturday, August 3 until 6:00 p.m. Monday, August 5** in the following areas:

- The **Cape Alitak, Alitak Bay, Moser Bay, and Olga Bay Sections** of the of the **Alitak District**.

There will be a **57-hour** commercial salmon fishing period from **noon Monday, August 5 to 9:00 p.m. Wednesday, August 7** in the following areas:

- The **Southwest Afognak Section** of the **Afognak District**;
- The **Northwest Kodiak District** (except the Anton Larsen Bay, Kizhuyak Bay, Terror Bay, Spiridon Bay, Zachar Bay, and Uyak Bay Sections will remain closed); and
- The **Outer Ayakulik and Halibut Bay Sections of the Southwest Kodiak District**.

Closed Water Adjustments:

Closed waters are **expanded** until further notice, in that portion in the **Southwest Afognak Section** of the **Afognak District**, within one-half nautical mile of the beach near the terminus of Malina Creek (stream #252-105) between 58° 10.00' N lat. and 58° 11.00' N lat.

As previously announced:

The following areas remain **open until further notice**:

- The **Izhut Bay, Outer Kitoi Bay, and Inner Kitoi Bay Sections** of the **Afognak District**; and
- The **Spiridon Bay Special Harvest Area** (Telrod Cove).

Closed Water Adjustment:

Closed waters are **reduced** until further notice in the **Inner Kitoi Bay Section** to the ADF&G markers located in Little Kitoi and Big Kitoi bays (near stream #s 252-323 and 252-324).

Until further notice, in the **Kodiak Area (including the Mainland District) Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear** in the commercial fishery and must be returned to the water unharmed.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon
