2025 SOUTHEAST ALASKA CHINOOK SALMON RUN FORECASTS

The 2025 Chinook salmon run forecasts for the Situk, Chilkat, Taku, Stikine, and Unuk Rivers stocks have been completed. These forecasts are germane to "large" fish that are at least 28" in total length and are based on recent brood year age at return and run data along with performance-based hindcasts.

Chinook salmon forecast for:

- Situk River total run is 750 large fish, within the escapement goal range of 450 to 1,050 fish.
- Chilkat River total run is 3,000 large fish, within the escapement goal range of 1,750 to 3,500 fish.
- Taku River terminal run is 40,000 large fish, **above** the escapement goal range of 19,000 to 36,000 fish.
- Stikine River terminal run is 10,000 large fish, below the escapement goal range of 14,000 to 28,000 fish.
- Unuk River total run is 2,600 large fish, within the escapement goal range of 1,800 to 3,800 fish.

The department monitors and has escapement goals for 11 Chinook salmon stocks in Southeast Alaska. In 2024, 8 of these 11 stocks achieved their escapement goals. In October 2024, the Alaska Board of Fisheries removed 3 of these stocks (i.e., Chilkat, Unuk, and Chickamin Rivers) as Stock of Management Concern (SOC) while retaining SOC status on 4 stocks (i.e., Taku, King Salmon, and Stikine Rivers and Andrew Creek).
