Nelchina Caribou Hunting Season Dates Extended

(Glennallen) – Caribou hunters in Game Management Unit 13 will have an additional 10 days of hunting this September. In an effort to increase harvest on the Nelchina caribou herd the Alaska Department of Fish and Game issued an emergency order extending all state caribou hunts in Unit 13 (YC495, RC561, RC562, CC001, DC475, and DC485) from September 21st through September 30th at 11:59 pm. The bag limit remains one caribou for all resident Unit 13 state-managed caribou hunts, and one bull caribou for the nonresident DC475 hunt.

The department's July 2020 Nelchina herd estimate was approximately 44,500 caribou. The fall (post-hunt) population objective for the Nelchina herd is 35,000–40,000 caribou. Caribou population objectives are based on the number of animals a given range can sustainably support. Too many caribou can over-graze a herd's range leading to malnutrition or starvation. Sometimes caribou will leave an over-grazed range or join up with adjacent herds for areas of better forage. The caribou herd has remained scattered in small groups across the landscape, largely in the western half of Unit 13. Fall hunt quotas have not been met by Nelchina permit holders and federal land closures to non-federally qualified hunters along the Richardson and Denali highways will further limit harvest by state hunters. This season extension will allow hunters to take advantage of additional harvest opportunity in the fall before the herd migrates off state land and out of Unit 13.

Hunters are reminded that if you have already filled your registration, draw, or federal subsistence permit this season no additional state opportunity remains. Hunters who have reported unsuccessful hunts or "did not hunt" are encouraged to have their permit reissued. The department also anticipates the winter season to remain open for all hunts although there is no assurance of a significant number of caribou being available in Unit 13 over the winter.

Successful hunters can provide wildlife managers the information they need to closely track in-season harvest by filing hunt reports online at hunt.alaska.gov, by phone at (907) 822-3461 (24/7), or in person at the Glennallen or Palmer Fish and Game offices. Hunters are reminded that hunts may still be closed by emergency order should harvest be excessive, but this is not anticipated at this time.
