Undersubscribed Black Bear Drawing Permits Available

For Game Management Units 1C and 1D

For Fall 2019/Spring 2020

Hunts: DL018, DL019, DL020, and DL021

The nonresident black bear drawing hunts in Units 1C and 1D were undersubscribed during the drawing process. Permits for these hunts are available on a first-come first-served basis. The Undersubscribed Hunt Application (attached below) should be submitted via fax (907-465-4272), email (paul.converse@alaska.gov), or in person to the Alaska Department of Fish and Game office in Douglas. These hunts are limited to nonresidents not using a registered guide.

DL018: 1C, South – Season dates: September 1, 2019 – June 30, 2020; Nonresidents only.

DL019: 1C, North – Season dates: September 1, 2019 – June 30, 2020; Nonresidents only.

DL020: 1C, Remainder – Season dates: September 1, 2019 – June 30, 2020; Nonresidents only.

DL021: 1D – Season dates: September 1, 2019 – June 30, 2020; Nonresidents only.

A hunter may possess only one undersubscribed black bear permit at a time. Nonresident hunters are limited to one black bear per regulatory year in Southeast Alaska.

If you are awarded a permit before June 15, 2019, it will be mailed to you with an estimated arrival time of July 1-15, 2019. If you are awarded a permit after this time, your permit will be mailed to you within approximately two weeks after we receive your application.
