Black Bear Permits Available Game Management Unit 3 Fall 2019/Spring 2020

The nonresident black bear drawing hunt in the "Remainder of Unit 3" was undersubscribed during the drawing process. This hunt is limited to nonresidents **not using an Alaska-licensed guide**. Permits for this hunt are available on a first-come, first-served basis.

If you are awarded a permit prior to June 15, 2019, it will be mailed to you with an estimated arrival time of July 1-15, 2019. If you are awarded a permit after this time, your permit will be mailed to you within approximately two weeks after your application is received.
