Discussion was focused on the changes that the Middle Yukon communities are faced with concerning climate change, multiple instances offered of how animal and fish behavior is different. Concern with the rigidness of hunting seasons with these changes.

Concern with nonlocal hunters taking moose; planes coming into remote locations and potentially taking illegal moose.

Interest in more local people getting the local drawing hunt permits as well as unallocated drawing hunts.

Concern voiced over the state not caring about the subsistence needs of the people, that the state makes money off guided nonresident hunters and that those people are who it caters to.
