**Alaska Board of Game Delays 2020/2021 Call for Proposal Deadline**

*New Call for Proposal deadline: May 15, 2020.*

Given complications associated with the COVID-19 pandemic, the Alaska Board of Game (board) is delaying its 2020/2021 Call for Proposals deadline to May 15, 2020.

The board is seeking regulatory proposals for changes in the hunting and trapping regulations for the Central/Southwest Region (Game Management Units 9, 10, 11, 13, 14A, 14B, 16, and 17), Statewide Regulations 5 AAC Chapter 92, and Areas of Jurisdiction for Antlerless Moose Hunts 5 AAC 98.005.
