PROPOSAL 55

Background

A concern the proposer mentions is the number of moose/vehicle collisions in the Matanuska Valley, Anchorage, and on the Kenai Peninsula. Moose/vehicle collisions vary annually due to numerous factors including weather conditions, visibility, lack of daylight, road conditions, vehicle speed, vehicle volume and snow depth.

Background (Cont.)

- ➤ During RY 2022 there were numerous opportunities for residents to harvest cow moose and for nonresidents to obtain bull moose draw permits in Southcentral Region Units. Most of the opportunity occurred in Unit 14(C).
 - ➤ 8 draw hunts were open to residents and nonresidents in Unit 14(C). Up to 185 permits could be issued for all hunts combined. Four hunts were bull only, 3 were either sex, and 1 was antlerless only. A total of 121 permits were issued, 32 bulls and 20 cows were harvested.
 - ➤ 1 bull only draw hunt open to residents and nonresidents in Unit 14(C). Up to 60 permits available, 40 permits were issued, 17 bulls were harvested.
 - ➤ 2 bull only draw hunts open to residents and nonresidents in Unit 14(C). Up to 100 total permits available, 20 permits were issued, 4 bulls were harvested.

- ➤ 1 bull only draw hunt open to residents and nonresidents in Unit 14(C). Up to 25 permits available, 3 permits were issued, 0 bulls were harvested.
- ➤ 2 antlerless draw hunt open to residents and nonresidents in Unit 14(C). Up to 100 permits available, 13 permits were issued, 4 cows and 2 bulls were harvested.
- ➤ 1 antlerless draw hunt open to residents only in Unit 14(C). Up to 70 permits available, 35 permits were issued, 12 cows were harvested.
- ➤ 2 antlerless draw hunt open to residents only in Unit 14(C). Up to 120 permits available, 10 permits were issued, 8 cows were harvested.

➤ 1 antlerless draw hunt open to resident and nonresidents in Unit 15(C). Up to 100 permits available, 50 permits were issued, 29 cows were harvested.

PROPOSAL 56

Background

- ➤ It is unlawful to take big game from a boat in Units 1-5; however, a person with physical disabilities as defined in 16.05.940, may hunt from a boat under authority of a permit issued by the Department.
- ➤ It is unlawful to take black bear from a boat in Unit 6(D); however, a person with physical disabilities as defined in 16.05.940, may hunt from a boat under authority of a permit issued by the Department.

Background (Cont.)

- ➤ "Big game" means black bear, brown bear, bison, caribou, Sitka black-tailed deer, elk, mountain goat, moose, muskox, Dall sheep, wolf, and wolverine; "big game" for the purposes of a youth hunt, does not include bison or muskox.
- ➤ "Boat" means a vehicle, vessel, or watercraft operated in or on water deep enough to float it at rest and includes hovercraft, airboats, personal watercraft, and amphibious vehicles.

PROPOSAL 57

Background

- ➤ It is illegal to take fur animals by using a trap, snare, net, fish trap, or dog, except in Unit 20(D) a dog may be used to hunt coyotes after registering with the Department and the Department may use its discretionary authority under 5 AAC 92.052 as needed.
- Fur animal means a beaver, coyote, artic fox, red fox, lynx, flying squirrel, ground squirrel, or red squirrel that has not been domestically raised and a fur animal is a classification of animals subject to taking with a hunting license.

Background (Cont.)

- > It is legal to use dogs to retrieve waterfowl and small game.
- Adopting this proposal should have no impact on the fur animal population if dogs are only used to track and retrieve mortally wounded or dead fur animals.

Background

- ➤ All goat hunting opportunities in Units 6-8, 14(C), and 15 are managed through drawing or registration hunts.
- The number of permits available for some hunts are based on "goat points". In most Units, a harvested billy counts as 1 point and a harvested nanny counts as 2 points.
- There are also numerous hunts with an unlimited number of permits available, but the season may close when a predetermined number of "goat points" or individual goats, are harvested.

Background (Cont.)

- During RY 2022, permits were issued for 34 goat drawing hunts and 38 goat registration hunts throughout the Southcentral Region. Of those, only 4 required goat hunter orientation and passing a quiz.
- ➤ Overall, goat populations in Units 6-8, 14(C), and 15 are stable. Managers can modify the number of permits issued annually based on their most recent survey and harvest data.

- ➤ As a reminder, currently there are no moose in Unit 8, so this proposal only pertains to Units 6, 7, 14(C), and 15.

A legal bull to harvest varies for the permit hunts, but it is usually limited to a specific antler configuration for the general season hunts.
